PROFESSIONAL EXPERIENCE

Scott Drimie is a researcher and facilitator working on food systems in southern Africa. Taking a largely political economy lens, he has focused primarily on food policy and the facilitation of new institutional arrangements for food system governance.

Scott leads a research and facilitation consultancy focused on food systems and livelihoods in southern Africa. Working with associates in this region, Scott consults for various public and private sector organisations (see below for details).

Complimenting this, Scott's academic work pivots on his role as an Associate Professor (Extraordinary) in the Centre for Complex Systems in Transition (CST) in the School of Public Leadership, Faculty of Economic and Management Sciences and the Department of Global Health, Faculty of Health and Medicine Sciences, both at Stellenbosch University. This work includes the development and teaching at Masters-level, supervision and examination of PhD and Masters candidates, and participation in Faculty related processes. He convenes a research programme on food systems at CST and he co-designs and facilitates learning processes across many of the thematic areas at the Centre.

Scott has directed the Southern Africa Food Lab (www.SouthernAfricafoodlab.org) since October 2013. This is a multi-stakeholder initiative that brings together stakeholders in the regional food system to identify and pilot innovative means to achieve long-term, sustainable food security. This is done through the use of collaborative learning and facilitation approaches. The Food Lab is housed at Agri-Sciences at Stellenbosch University.

Scott was a Research Fellow with the International Food Policy Research Institute (IFPRI) between 2007 and 2011. His responsibility was the coordination of the Regional Network on AIDS, Livelihoods and Food Security - RENEWAL (www.ifpri.org/renewal) - which facilitated research on the interactions between HIV and food and nutrition security and the implications for policy and practice in southern and eastern Africa.

Between 2001 and 2005, Scott was a Senior Research Specialist in the Integrated Rural and Regional Development Programme at the Human Sciences Research Council in South Africa. His primary focus was on land reform and food security work.

In 2000 he completed his PhD at Cambridge University, which focused on the implementation of the South African land policy in the period 1994–1999. He spent a short period at the Department of Rural Development Studies at Uppsala University, Sweden before returning to South Africa. Since then, his research has focused on food systems and food security and the role of multiple stressors affecting the well being of vulnerable groups.

Scott is currently supervising five PhD students (see details below) and around ten Masters' students per year across three faculties (Agri-Sciences, Economics and Management Sciences and Health and Medicine Sciences) at Stellenbosch University (and one at the University of Witwatersrand).

Regional Inter-Agency Support Committee, SADC, November 2015 – April 2016

Employed to facilitate two separate processes for RIASCO including a strategic review of the SADC Resilience Strategy and the facilitation of the RIASCO Resilience Initiative Conversation. This included facilitating discussions among regional participants from the United Nations and Internal NGOs working in southern Africa towards making a decision on the feasibility of a formal, long-term commitment to establish a resilience approach in the region. These discussions included disagreement with the current approach, including reasons for failure and proposing alternative options that would contribute to joint interagency work.

This was an analytical and consultative exercise that identified the key challenges and provided prioritized areas for action for the Government and its development partners. The process contributed to the Zero Hunger Challenge and informed the emerging Sustainable Development Goal Two in Namibia. The findings informed Namibia's food security strategy and national development planning. The review intended to help development partners understand the support required to reach internationally agreed upon food and nutrition security goals.

International Food Policy Research institute, January 2014 – June 2016

Part of a team led by IFPRI to document "stories of change" in nutrition. Focusing on Zambia, the assignment involves identifying and analysing the fundamental mechanisms by which action for nutrition has been initiated and helped to progress and scaled up. The project applies tools, methods and approaches in selected countries including Bangladesh, Ethiopia, India, Nepal, Senegal and Zambia to document experiences in order to engage with, influence and evaluate action to reduce undernutrition.

Part of team commissioned by Cornerstone Economic Research to undertake expenditure and performance review of all government programmes intended to address children’s food and nutrition insecurity. This entailed developing programme elements of two nutrition interventions that are part of the Nutrition and Food Security Programmes for Children, contributing to a log frame of the process of policy implementation and input to and reviewing of the costing model, that will focus primarily on the cost of managing such programmes.

Scaling Up Nutrition, Zambia, January 2015 – August 2015

The assignment involved developing clear and practical guidelines and support to several District Nutrition Coordinating Committees to become effective coordination mechanisms for the First 1,000 Most Critical Days Programme (MCDP). The work involves developing a clear vision, defined roles and responsibilities, practical delivery channels and a basic monitoring plan in collaboration with several Coordinating Committees. At the end of the assignment the SUN Fund Core Team was able to replicate the training and support for all district coordinators as necessary.

Scaling Up Nutrition, Zambia, November 2014 – December 2014

On behalf of the SUN Fund Core Team, developed clear and practical programme implementation pathways for the priority interventions devised to address malnutrition in Zambia. This was in order to clarify the delivery channel for each priority intervention thereby making monitoring and process evaluation effective and efficient.
