2. PRIVATE VEHICLES for official use:

In terms of the tax laws an employee who does not receive a monthly transport/travel allowance is permitted to claim up to **R3.82**per km from 1/3/2021 tax free. Claims amounting to more than R3.82 per km mean that the total claim becomes taxable and not only the portion above R3.82 per km. Claims from employees who do receive a transport/travel allowance, including those amounting to less than R3.82 per km, are fully taxable. In view of this, it would in most cases not be advisable to claim more than R3.82 per km.

Important Notice from Finance:

Reimbursement of private transport claims must be done within three (3) months of the actual trip and will be strictly enforced to ensure an error free claim and ample time for the tax and audit period.

When working from home during lock-down:

Being between home and workplace the km can unfortunately not be claimed according to SARS. If it is not part of normal functions you could compensate via salary system. If distance from home to 'site' is no longer amounted to than from workplace to 'site' it can be claimed in other words actual distance, but if it is more than from normal workplace then only the distance between work and site.
